ORDER

NO.SO(TT)12-2/2014. In continuation to this department's notification bearing No.SO(Tax) 1-31-98(Vol-III) dated 18.06.2015 (copy enclosed), it is hereby specified that with effect from 1st of July, 2015, 32-A challans meant for deposit of money into the bank for the purpose of purchase of non-judicial and court fee stamps valuing more than or a thousand rupees shall not be required to be signed by the Treasury Officer, Lahore their presentation to the bank. In absence of a direction to the contrary, the bank on accept 32-A challans relating to non-judicial and court fee stamps valuing more than one thousand rupees except those generated from the website www.estamp.punjab.gov.pk.

2. 32-A challans required to be submitted by the stamp vendors and the challans meant for deposit of money for the purpose of purchase of special adhesive stamps, insurance policy stamps, share transfer stamps, foreign bill stamps, revenue stamps, service stamps, notarial stamps and hundi stamps shall continue to be signed by the Treasury Officer, Lahore, or his authorized subordinates as is being done at present.
